HCBS Medicaid Waiver Funding Cuts Anticipated Statewide!!

During the pandemic there was a program called the American Rescue Plan Act (ARPA) that provided financial assistance, in various forms to states to recover. The Wyoming Legislature chose to use some of this money, \$3.86 million to pay some of the state's share of home and community based waiver costs to increase rates for services. ARPA money must be used and will end on March 31, 2025. If that money is not replaced, rates to providers of these services will be reduced to 2022 rates. As you would imagine, 2022 rates are much less than the current rates, some by as much as 43.1%. That is not sustainable. We are not asking for anything additional, just to not be cut back to 2022 rates.

One of the requirements of the ARPA dollars was that they had to be used for wages and benefits for the Direct Support Professional Workforce. LSR complied with that requirement and raised our DSP's wages. Which are still below many private sector businesses. Our hard-working DSPs are working class people who sometimes need to work multiple jobs just to make ends meet and reducing existing wages would make that even more difficult for them. They are members of our community who live, work, shop, and purchase services here.

We need everyone's help in letting our Wyoming State elected officials know that not covering the reduction in ARPA funds to the HCBS Medicaid Waivers with general state dollars will have a major impact on services being provided to individuals with disabilities in Wyoming.
